Course & Birds: All stakes will be run using a single course without a bird field. All stakes will have quail, chukkar, and/or stocked pheasants released. A blank cartridge **will** be fired in all stakes. Current AKC rules regarding blank guns and tracking collars apply.

Trial Site: Ottawa Field Trial Area – W367S5302 WI-67, Eagle, WI 53188

LUNCHES: Lunch will be available at the grounds Saturday and Sunday for a nominal fee.

TRIAL FORMAT: This trial is being run under the flexible format option and the club reserves the right to rearrange the running order of the stakes and add / rearrange judges if conditions warrant.

INCLIMATE WEATHER PROVISION: A determination will be made prior to the drawing by the VCGM Board of Directors about the status of the trial. In the event of cancellation due to weather, entries will be refunded.

ENTRY LIMIT: Entries will be limited to the number of dogs that can be run during daylight hours or approximately 60 dogs. A wait list will be maintained once the limit is reached. Handlers are encouraged to limit entries to 6 dogs per stake.
